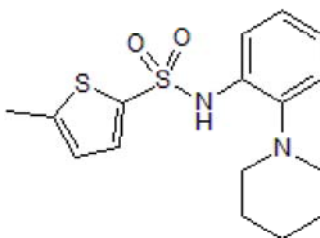

**Description:**

TRPML channel activator ( $EC_{50}$  = 110 nM). Also activates F408 $\Delta$  and F465L TRPML mutants ( $EC_{50}$  values are 0.1 and 1.23  $\mu$ M respectively). Restores endolysosomal trafficking and zinc homeostasis in lysosomes of mucopolipidosis type IV (MLIV) mutant fibroblasts.

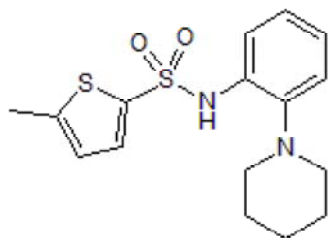

**Stability and Solubility Advice:**

Some solutions can be difficult to obtain and can be encouraged by rapid stirring, sonication or gentle warming (in a 45-60°C water bath).
